

# DESERT HEALTHCARE DISTRICT: REQUEST FOR PROPOSALS

Throughout the year, the Desert Healthcare District releases Request for Proposals and partners with organizations that align with its current Strategic Plan.



#### 2022 Mental Health Initiative Request for Proposals

In partnership with the Regional Access Project Foundation, a Mental Health Initiative request for proposals was released to meet, improve, and increase access to mental health services and resources targeting primarily lowincome eastern Coachella Valley residents with an emphasis on Black, Indigenous, People of Color family units with children.



A total of **\$600,000** was awarded, by the partnership, to **14 organizations** across the Coachella Valley.

#### 2023 Health/Mental Health Request for Proposals

In partnership with the Regional Access Project Foundation, a Health/Mental Health request for proposals was released to fund programs/projects that advocate improving the psychological, emotional, physical, and social wellbeing of residents north of Palm Springs to Blythe. Specifically, approved applicants sought to accomplish at least one of the following goals:

- Improve quality of mental health services to remote areas through innovative systems that address policy, access, and delivery channels.
- Improve awareness of mental and emotional health resource services for residents north of Palm Springs to Blythe through systems that address access, policy, and delivery channels.
- Support cultural competency of service providers and reduction of language/stigma/cultural barriers to service access for clients.



A total of **\$1,000,000** was awarded, by the partnership, to **24 organizations** across the Coachella Valley.

Improving Access to Behavioral Health Education and Prevention Services to Children (0-18 years) and their Families Request for Proposals

In response to working group convenings of the Coachella Valley Behavioral Health Initiative and outreach efforts to local school district leadership, the Desert Healthcare District released a request for proposals that focused on improving access to behavioral health education and prevention services to children (0-18 years) and their families. Specifically, the District sought applicants that focused on behavioral health access, awareness, availability, and education. Approved applicants provided education and/or preventative services that worked to accomplish at least one of the following goals:

- Increase access to behavioral health services and resources to children (0-18 years) and their families.
- Improve awareness of behavioral health services and resources to children (0-18 years) and their families.
- Expand availability of behavioral health services and resources to children (0-18 years) and their families.
- Increase education of behavioral health services and resources to children (0-18 years) and their families.

A total of **\$1,175,817** was awarded, by the Desert Healthcare District, to **5** organizations across the Coachella Valley.

## Building Connected Communities: Improving Community Supports to Reduce Social Isolation and Loneliness Request for Proposals

In response to the uplifted and prioritized needs expressed by the convening of local community stakeholders, the District and Foundation is sought proposals from organizations to build connected communities by improving community supports to reduce social isolation and loneliness. Specifically, the District and Foundation sought projects that addressed isolation and loneliness through the recruitment, retainment, and training of community navigators to improve connectedness. Approved applicants worked to reduce social isolation and loneliness with alignment to the below strategies:

- Increase the number of community navigators serving Coachella Valley residents.
- Increase awareness and access to behavioral/mental health resources.
- Improve access to community support services through systems and environments that build connectedness.

A total of **\$1,074,113** was awarded, by the Desert Healthcare District, to **8** organizations across the Coachella Valley.

### Mitigating Air Quality-Related Health Conditions: Prevention, Diagnosis, and Management

The District and Foundation hosted a community data walk to engage local organizations, service providers, residents, and stakeholders in discussions on the impacts of air pollution. Participants reviewed data on hospital use, economic impact, pollution sources, health disparities, and air quality-related health conditions. They shared insights, identified challenges, and explored opportunities to improve air quality and health outcomes. Key themes included prevention strategies, better diagnosis of air-related health issues, and improving access to health services. In response to the needs prioritized by local stakeholders, an RFP was developed and released. Approved applicants had projects that aimed to prevent, diagnose, and manage air quality-related health conditions for Coachella Valley residents, aiming to accomplish at least one of the following strategies:

- accomplish at least one of the following strategies:
   Increase and enhance awareness and foster connections to mitigate the impact of air quality on health conditions and outcomes.
  - Evaluate household environments to identify methods for improving indoor air quality.
- Increase access to health services to reduce the impact of poor air quality on health.

A total of **\$997,353** was awarded, by the Desert Healthcare District, to **5** organizations across the Coachella Valley.
